ORDINANCE NO. 13 - 09

**APPROVING ALTERATION OF SPEED LIMITS  
VARIOUS ROADS – AURORA TOWNSHIP**

WHEREAS, the County of Kane through its Division of Transportation has caused an engineering and traffic investigation to be conducted on various highways not otherwise under the jurisdiction of the Illinois Department of Transportation; and

WHEREAS, the Transportation Committee of the Kane County Board has reviewed the results of said investigation and has recommended the alteration of the existing maximum speed limits of thirty (30) miles per hour as set forth in the Illinois Vehicle Code, (625 ILCS 5/11-604), so as to be both reasonable, safe and proper.

NOW, THEREFORE, BE IT ORDAINED by the Kane County Board, that pursuant to the Illinois Vehicle Code, (625 ILCS 5/11-604), the maximum speed limit on the section of highways as described hereunder shall be twenty five (25) miles per hour as indicated in the schedule as set forth below.

BE IT FURTHER ORDAINED that this Ordinance shall be effective upon the approval of the Kane County Board as provided by statute and the posting of signs giving notice of said twenty five (25) miles per hour maximum speed limit.



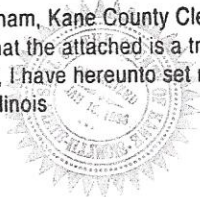
